ACKNOWLEDGEMENT OF RISK, RELEASE OF LIABILITY AND AGREEMENT WAIVER

I am applying for my child’s admission to the Miramont Lifestyle Fitness nursery/clubhouse. I understand and acknowledge that there are hazards, risks and dangers outside of the control of Miramont Lifestyle Fitness associated with my child’s use of the nursery/clubhouse and/or childcare services and activities associated therewith, and that these can cause or result in injury, illness, property damage or loss and possibly even death. On behalf of my child, I accept all risks, even if they are created by the carelessness or negligence of Miramont Lifestyle Fitness’ employees, volunteers, agents, independent contractors, contract-employees and any other personnel in any way assisting or connected with Miramont Lifestyle Fitness’ nursery/clubhouse. I further understand and acknowledge that I have voluntarily elected to use the daycare and nursery services provided by Miramont Lifestyle Fitness and allow my child to participate in all activities associated therewith, with full knowledge of the risks and dangers involved, and I hereby agree to accept any and all risks of personal injury, illness, property damage or death to my child resulting from or relating to participation in the nursery or daycare provided by Miramont Lifestyle Fitness and all activities associated therewith.

In consideration of my child’s use of or participation in the nursery or childcare services provided by Miramont Lifestyle Fitness and all activities associated therewith, I, for myself and my child and any executors, administrators, heirs, successors, representatives and assigns, hereby release, waive, discharge and hold harmless Miramont Lifestyle Fitness and their sponsors, officers, directors, stockholders, managers, employees, associates, representatives, agents and assigns of each of these entities (collectively “released parties”) from any liability, claims or actions, including, without limitation, claims for negligence, property damage, personal injury or wrongful death, that I or my child or any executors, administrators, representatives, heirs, successors or assigns may have or which may hereafter accrue as a result of my child’s use of or participation in the nursery/clubhouse services provided by Miramont Lifestyle Fitness. I understand and intend that this document act as the broadest and most inclusive assumption of risk, waiver, release of liability agreement not to sue and indemnify as is permitted by the laws of the State of Colorado.

I further understand and agree that my child is allowed to stay in the nursery/clubhouse for a maximum of 2 ½ hours (for children two and older), 2 hours (for children under two years of age) on any given day. I understand and acknowledge that I must remain on the premises at all times while my child is in the nursery/clubhouse.

EMERGENCY MEDICAL AUTHORIZATION

I hereby authorize any licensed physician, emergency medical technician, hospital or other medical or health care facility to treat myself or any minor for which I am the parent or legal guardian named herein for the purpose of attempting to treat or relieve any injuries received by said person arising out of or relating to Miramont Lifestyle Fitness. I authorize any such medical provider to perform all procedures deemed medically advisable in attempting to treat or relieve any such injuries. I consent to the administration of anesthesia as deemed advisable. I realize and appreciate that there is a possibility of complication and unforeseen consequences in any medical treatment, and I assume any such risk for and on behalf of my child and myself.
